1. This invitation for expression of interest follows the General Procurement Notice (GPN) which appeared in PPRA Portal Issue No. 2021-2022 dated 1<sup>st</sup> July, 2021
2. The Government of the United Republic of Tanzania has set aside funds for the operation of the Tanzania Communications Regulatory Authority during the financial year 2021-2022. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for provision of consultancy services for determination of cost based interconnection and retail services charges in Tanzania Telecommunication Market.
3. The Tanzania Communications Regulatory Authority now invites eligible *consulting firms* to indicate their interest in providing consultancy services for determination of cost based interconnection and retail services charges in Tanzania Telecommunication Market and for a period of six months.
4. Interested *consulting firms* must provide information indicating that they are qualified to perform the services by submitting the following:-

**(i) Consultant's profile indicating legal and constitutional status of the company/firm including valid business licenses if applicable**

**(ii) Submit description of similar assignments indicating amount for each assignment, nature of the assignment, name of employer(s), contact address and year of completion;**

**(iii) Submit curriculum vitae indicating evidence on the availability of appropriate skills among staff proposed to carry out the assignment.**

**(iv) To demonstrate financial capability to perform the assignment, you are required to submit audited financial statements for three consecutive years (2018, 2019 and 2020)**

Consultants may associate to enhance their qualifications.

5. A consultant will be selected in accordance with the procedures set out in the Public Procurement Act No. 7 of 2011 as amended in 2016 and the Public Procurement Regulations, 2013 – Government Notice No. 446 as amended in 2016 (hereinafter called Procurement Regulations).
6. Selection will be conducted through the **Quality and Cost based** Selection procedures specified in the Public Procurement Regulations.
7. Interested *consulting firms* are required to register in the National online procurement system (TANePS) through **Website: [www.taneps.go.tz](http://www.taneps.go.tz)**.
8. Interested eligible consultants may obtain further information from the office of the *Tender Board Secretary of the TCRA* from 9.00 am to 4.00 pm on Monday to Friday inclusive except on public holidays.
9. Expressions of Interest (EoI) must be delivered online through TANePS portal on the day, date and time indicated in the TANePS.
10. Late Expressions of Interest shall not be accepted for evaluation irrespective of the circumstances.
