THE ELECTRONIC AND POSTAL COMMUNICATIONS (RADIO AND TELEVISION BROADCASTING CONTENT) (AMENDMENT) REGULATIONS, 2022

1. These Regulations may be cited as the Electronic and Postal Communications (Radio and Television Broadcasting Content) (Amendment) Regulations, 2022 and shall be read as one with the Electronic and Postal Communications (Radio and Television Broadcasting Content) Regulations, 2018, hereinafter referred to as the “principal Regulations”.
- Amendment of regulation 3
2. The principal Regulations are amended in regulation 3 by deleting the words “one point” appearing in the definition of the term “district licence” and substituting for them the words “up to three points”.
- Amendment of regulation 37
3. The principal Regulations are amended in regulation 37, by-
- (a) deleting subregulations (2) and (3) substituting for them the following:
- “(2) Subject to subregulation (1)(d), the licensee shall notify the Authority in writing prior to hook up with any local or foreign station.
- (3) The licensee who hooks up shall be responsible for any content which does not comply with the requirements of the Act or these Regulations.”; and

(b) deleting sub regulation (4).

Amendment of
regulation 39

4. The principal Regulations are amended in regulation 39 by adding immediately after subregulation (5) the following:

“(6) A licensee shall maintain copies of all broadcast transmission recordings for ninety days.”.

Addition of new
regulation 45A

5. The principal Regulations are amended by adding immediately after regulation 45 the following new regulation:

“Radio
programmes
Telecast on
Television

45A. Radio station programmes may be telecasted on television channels, but the telecasted programmes shall not exceed twenty per cent of total number of radio programmes aired per month.”.
