**1.0 DEFINITION**

In this licence, unless stated otherwise or the context otherwise requires:-

- 1.1.1 **“Acts”** means the Tanzania Communications Regulatory Authority Act No.12 of 2003, Tanzania Communications Act No.18 of 1993 and Broadcasting Services Act No.6 of 1993.
- 1.1.2 **“Authority”** means the Tanzania Communications Regulatory Authority
- 1.1.3 **“Licence”** means authority to use radio frequency spectrum resource and operate radio station (s)
- 1.1.4 **“Licensee”** means any person holding this licence

**2.0 SCOPE OF THE LICENCE**

- 2.1 The Tanzania Communications Regulatory Authority (herein referred to as the “Authority”) in accordance with Section 6 of the Tanzania Communications Regulatory Act, 2003 and Section 11 of the Tanzania Communications Act, 1993 (herein referred to as the “Act”), hereby grants a licence to ..... (herein referred to as the “Licensee”) to use radio frequency spectrum resource and operate radio station (s)
- 2.2 The Licensee is authorized to use radio frequency with the following specifications: (more space is provided in appendix I)
  - 2.2.1 Assigned centre frequency/ies.....
  - 2.2.2 Assigned bandwidth.....
  - 2.2.3 Type of equipment.....
  - 2.2.4 Area of operation.....
  - 2.2.5 Operating power.....

**3. DURATION AND RENEWAL OF THE LICENCE**

- 3.1 The Licence is valid for a period of one (1) year. The Licence may be further renewed on annual basis subject to such terms and conditions as may be specified by the Regulatory Authority.
- 3.2 The Licence terminates upon expiry of the licence term and if not renewed.

**5.0 LICENCE FEES**

- 5.1 The Licence Fees in respect of this Licence and its renewal shall be as determined by the Authority.
- 5.2 In addition to any licence application fee paid by the Licensee, the Licensee, shall pay to the Authority annual fees of .....

**6.0 COMPLIANCE WITH THE LAW**

The Licensee shall comply with the provision of the Act and other laws of the United Republic of Tanzania.

**7.0. COMPLIANCE WITH REGULATORY REQUIREMENTS**

The Licensee shall comply with the provision of the Authority regulations and rules issued under the Act.

**8.0. COMPLIANCE WITH SPECTRUM PLAN**

The Licensee shall comply with the spectrum plan issued under the Acts.

**9.0 INDEMNITY**

The licensee shall indemnify the Authority against any claims or proceedings arising from any breach or failings on the part of the Licensee.

**10.0 SAFETY MEASURES**

The licensee shall in respect of services operated, maintained or offered under this licence take all proper and adequate safety measures to safeguard life or property, including exposure to any electrical emission or radiations emanating from equipment or installation from such operations.

**11.0 EFFICIENT USE**

The Licensee shall use the assigned frequency in an efficient manner.

**12.0 AVOIDANCE OF HARMFUL INTERFERENCE**

The Licensee shall take all reasonable steps to ensure that the use of the assigned frequency does not cause harmful interference with facilities of other network service providers.
