LICENCE GRANTED BY TANZANIA COMMUNICATIONS REGULATORY AUTHORITY TO FOR THE INSTALLATION AND MAINTENANCE OF ELECTRONIC COMMUNICATION EQUIPMENT IN THE UNITED REPUBLIC OF TANZANIA

1.0 DEFINITION

1.1 In this licence, unless stated otherwise or the context otherwise requires:-

1.1.1 **"Act"** means the Tanzania Communications Regulatory Authority Act, 2003

1.1.2 **"Authority"** means the Tanzania Communications Regulatory Authority

1.1.3 **"Licence"** means the licence to install and maintain electronic communication equipment

1.1.4 **"Licensee"** means any person holding this licence

2.0 SCOPE

The Tanzania Communications Regulatory Authority (herein referred to as the "Authority") in accordance with Section 6 of the Tanzania Communications Regulatory Authority Act, 2003 and Section 11 of the Tanzania Communications Act, 1993 (herein referred to as the "Act"), hereby grants a licence to (herein referred to as the "Licensee"). to install and maintain electronic communication equipment.

3.0 DURATION AND RENEWAL OF THE LICENCE

The Licence is valid for a period of one (1) year. The Licence may be further renewed on annual basis subject to such terms and conditions as may be specified by the Regulatory Authority.

4.0 OWNERSHIP AND CORPORATE OBLIGATION

The Licensee shall comply with the following conditions on ownership :-

4.1 to furnish the Authority a copy of their shareholding structure as required by the Communication Licensing Regulations

- 4.2 to notify the Authority in writing of any changes to its ownership and control structure.
- 4.3 to notify the Authority of any joint venture into which it enters with any other person or entity holding a licence issued by the Authority.

5.0 LICENCE FEES

The Licensee shall pay the Authority annual fees of

6.0 COMPLIANCE WITH THE LAW

The Licensee shall comply with:-

- 6.1 The provision of the Tanzania Communications Act 1993, TCRA Act 2003 and other laws of the United Republic of Tanzania.
- 6.2 The provision of any subsidiary legislation (including regulations and rules) made under the Act.

7.0 INDEMNITY

The Licensee shall indemnify the Authority against any claims or proceedings arising from any breach or failings on the part of the Licensee.

8.0 SAFETY MEASURES

The Licensee shall in respect of all apparatus, equipment and installations, possessed, operated, maintained or used under this licence, take all proper and adequate safety measures to safeguard life or property, including exposure to any electrical emission or radiation emanating from the apparatus, equipment or installations so used.

9.0 QUALITY OF SERVICES

The Licensee shall take all necessary measures to ensure that the installation and maintenance of electronic communications equipment are performed according to engineering standards.

10.0 INSTALLATION AND MAINTENANCE OF ELECTRONIC EQUIPMENT

10.1 The Licensee shall install and maintain equipment which are type approved by relevant International standardization bodies.

10.2 The Licensee shall import and distribute equipment which are Type Certified by the Authority.

11. CAPACITY BUILDING

11.1 The Licensee shall submit to the Authority the Human Resource Development Plan outlining strategic enhancement of the local success plan towards empowerment of local managers.

11.2 The Licensee shall facilitate participation of its technical staff in Training with or outside the United Republic of Tanzania
