1. This Invitation for Tenders follows the General Procurement Notice for this Project which appeared in the **Public Procurement Regulatory Authority (PPRA) portal of 3rd July, 2020**
2. The Tanzania Communications Regulatory Authority (TCRA) has set aside funds for its operations and intends to apply part of the funds to cover eligible payments for Supply, Installation and Commissioning of Radio Frequency Spectrum Planning System.
3. TCRA now invites sealed Tenders from eligible Suppliers for carrying out the **Supply, Installation and Commissioning of Radio Frequency Spectrum Planning System**.
4. Tendering will be conducted through National Competitive Bidding procedure specified in the Public Procurement (Goods, Works, Non Consultant Service and Disposal of Public Assets by Tender) Regulations, 2013–Government Notice No. 446 and is open to all tenderers as defined in the Regulations.

refundable fee of TZS.30,000.00. Payment shall be through the dedicated payment gateway integrated in the TANePS.
